#### ILN SEEKING NEW BOARD MEMBERS

The Indiana League for Nursing has several open positions on the Board of Directors. If you are a nurse educator or Professional Development Specialists who is willing to engage in state level leadership as a member or officer of the ILN Board of Directors, we want you! You need to be an active ILN member to serve in these roles. The ILN offers opportunities to develop leadership skills and network with other educators and Professional Development Specialists across the state.

We need three (3) board of directors' members for January 2022-2025 and a Treasurer for January 2022-January 2025.

<u>Board of Directors Responsibilities (3 positions):</u> The Directors provides oversight of all ILN functions including the strategic plan, the bylaws, the finances, public relations, and programs. Board members are engaged in the following ILN committees: legislative, public relations, program, global health, scholarship, and membership. Term January 2022-2025.

<u>Treasurer Responsibilities</u>. The Treasurer shall have the custody of all funds and securities of the Constituent League. The Treasurer shall be bonded in such amounts as determined by the Board upon recommendations of the Finance Committee. The Treasurer may endorse, for collection on behalf of the Constituent League, checks, notes, and other orders or obligations for the payment of money. The Treasurer shall have general responsibility for seeing that funds of the Constituent League are deposited to its credit in such banks as the Board may designate. The Treasurer shall see that only such bills as have been approved or otherwise authorized by the Board or designee are paid. The Treasurer shall see that full and accurate accounts are kept and audited annually by an internal auditing committee or by a certified public accountant and shall make a financial report to the Board at the regular meetings and to the membership at the annual meeting. The Treasurer shall perform such other duties as may be assigned by the Board. Term-January 2022-2025.

<u>Time commitment:</u> The Board of Directors meets virtually via Zoom or by teleconference 3-6 times per year. Our meetings usually last 1 hour. There are occasions of input or voting via email as well. Committee work is accomplished via email. The ILN hosts programs each year at venues volunteered by area nursing programs, or virtually if needed due to the pandemic. Each member of the Board serves a three- year term, except the president-elect is a 2-year term.

Commitment to the Indiana League for Nursing mission "to support and implement the mission of the National League for Nursing and to promote excellence in nursing education to build a strong and diverse nursing workforce to advance the nation's health at the constituent level."





### DEGREES, CERTIFICATIONS, SERVICE, RECOGNITION, AND GRANTS






